

BYLAW NO. 24-2013

A BYLAW OF THE TOWN OF ARCOLA TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND FOR THE USE OF SEWER

The Council of the Town of Arcola, in the Province of Saskatchewan, enacts as follows:

1. This Bylaw may be cited as the Utility Service Charge Bylaw.
2. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" & "B" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
3. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "C" & "D" attached.
4. Accounts for water service and/or sewer service shall cover a period of two months, and shall be rendered on or before the first day of the month next following such period. Bills will be sent out at the end of February, April, June, August, October, and December. Actual readings for both commercial and residential will be taken at least once a year. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of sixty days, the water service may be cut off.
5. Bylaw No. 4-2007 and Bylaw No.10-2008 are hereby repealed.
6. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee or March 1st, 2014 whichever is the later.
